**Subject: Elimination of identified Single-Use Plastics – regarding.**

In continuation to CBSE Circular No. ACAD-73/2021 dated 31st August, 2021, School Heads are requested to include activities for **banning / elimination of Single Use Plastic** in schools in Swachhata Pakhwada 2021 from 1<sup>st</sup> September to 15<sup>th</sup> September 2021. Some activities are suggested for elimination of single use plastic in schools in **Annexure-I**.

Single-Use Plastic drastically impacts the environment in a harmful way. Single-Use Plastic after usage mostly dumped on the land-fill sites chokes the water supply and drainage system and damages the environment due to its non-biodegradability.

School Heads are requested to create a strong public movement for mitigation of plastic pollution by adopting the strategy of 6Rs (Reduce, Reuse, Recycle, Recover, Redesign and Remanufacture) based on the principle of circular economy and facilitate development of an action plan for elimination of single use plastic in their school.
