MEMORANDUM OF THE SOCIETY

1. NAME OF THE SOCIETY : SRI SURYA EDUCATIONAL SOCIETY

2. OFFICE

: The Registered Office of the Society shall be situated within the Municipal Limits of the Twin-cities of Hyderabad and Secunderabad. The office of the Society shall be located at plot no.114&115, Road No.2 Tirumala Hills, Asmangadh, Malakpet, Hyderabad-36, Andhra Pradesh.

3. AIMS & OBJECTIVES:

- a. To impart primary, secondary and collegiate education to all in a healthy environment, to build a strong nation of intellectuals and promote literacy in our country.
- b. To establish and take over Educational Institutions and run the same.
- c. To promote standards of education in all aspects.
- d. To foater a spirit of unity and a spirit of enlightened and responsible citizenship through such educationaal institutions.
- e. To co-operate with other societies, institutions and organisations in pursuit of all or any of the above objects.
- f. To do all such things and to perform all such sets as may be necessary or proper for the achievement of any or all of the above objects.
- g. To award certificates and diplomas.
- h. Without prejudice to the generality of the above and for the effective carrying out of the above objects, the society shall have the power to acquire, receive and hold property of any kind, to construct and maintain buildings including the right to alter or improve them and to equip them suitably to manage, sell, transfer or otherwise dispose of or deal with property of any kind belonging to the society, to enter into contracts for and in connection with any of the purposes of the society, to raise funds in such manner as may deem fit for and behalf of the society, and to accept the management of any trust fund or endowment in which the society may be interested.

RULES AND REGULATIONS OF SRI SURYA EDUCATIONAL SOCIETY

1. LOCATION

: The Headquarters of the Society shall be kept at Hyderabad and its field of activity will extend to the whole of Andhra Pradesh.

Office of the society will be at plot no.114 & 115, Road No.2, Tirumala Hills, Asmangadh, Malakpet, Hyderabad-36, A.P.

2. INTERPRETATION

- a. 'Society' means Sri Surya Educational Society.
- b. 'Council' means the Governing Council of the Society.
- c. 'General Body' means the General Body of members of the society.

3. PATRONS

: The Council may invite much person/persons as it may deem fit, to be patrons.

4. MEMBERS

- : There will be the following classes of members.
 - a. Founder Members.
 - b. Life Members.
 - c. Ordinary Members.

Founder Members

: Founder Members are those who took active interest or part in the establishment of the society and are enrolled as such.

Life Members

: Life Members are those persons who are enrolled as such by payment of a lumpsum subscription of &.1,000/- to the society.

Ordinary Members

- : Ordinary Members are those who are enrolled as such by an Annual subscription of R. 100/and continue to pay on.
- 5. OFFICE BEARERS OF THE SOCIETY
- : The following will be the Office bearers of the Society.

 - 1. Chairman 2. Vice-chairman 3. Secretary/Correspondent
 - 4. Joint Secretary
 - 5. Treasurer

6. GOVERNING COUNCIL

: There will be a Governing Council composed of:

The Office bearers of the Society, namely the Chairman, Vice-Chairman, Secretary/Correspondent, Joint Secretary and Treasurer and not more than two members.

Not less than three founder members shall be elected to the Governing Council.

- 7. RIGHTS, POWERS AND DUTIES OF THE GOVERNING COUNCIL :
 - a. All properties, movable, immovable or any others kind, shall stand vested in the Council.
 - b. The Council shall have all such powers and shall perform all such functions so are necessary or proper for the achievement or the furtherence of the objects of the society.
 - c. Without prejudice to the generality of the foregoing provisions, the council shall have the following rights and powers:
 - To acquire by hire, purchase, exchange, loans or otherwise, lands, buildings, or other immovable property together with all rights as pertaining there to.
 - ii. Construct and maintain buildings including right to alter or improve and to equip them suitably.
 - iii. To manage the proportion of the Society.
 - iv. To raise funds for the society by gifts, donations, or otherwise, and to raise loans.
 - v. To sue and be sued on behalf of the Society.
 - vi. To manage, sell transfer or otherwise dispose of any property, movable or immovable of the society.
 - vii. To assign from time to time, such functions and duties, and delegate such powers, as may deem fit for the office bearers.
 - viii. To appoint an auditor or auditors for auditing the accounts of the society.
 - ix. To appoint from time to time such and so many employees and on such terms and conditions as may deem fit for carrying on the management and affairs of the society, and employees to work in the institutions of the society.
 - x. To appoint, from time to time, sub-committees, including if need be persons other then members of the governing council, and to assign and or delegate there into, such powers, duties and functions, as it may deem fit.

- xi. The General body shall meet at least once in a year in the month of March for purposes of electing the executive committee, for verifying the balance sheet and such this matters is may be placed before it.
- 8. DUTIES OF THE OFFICE-BEARERS:
- CHAIRMAN: The Chairman shall presides over all the meetings of the General Body and Executive committee.
 - He shall enter into agreements on behalf of the society.
 - He shall conduct all correspondence on behalf of the society.
 - iii. He shall be in supervision and maintenance of the properties of the society.
 - iv. He shall be the custodian of the finances of the society and he shall undertake all financial transactions. He shall receive amounts and make payments on behalf of the society.
 - v. He shall appoint staff to run the affairs of the society.
 - vi. He shall appoint staff to run the affairs of the society and its institutions as when required and shall take any action against the staff including disciplinary action for proper working of the institution.
 - vii. He can cast his vote in the case of tie. He can supervise all branches of society.
- VICE-CHAIRMAN: In the absence of the Chairman the Vice-Chairman shall preside over the meetings and discharge the functions of the Chairman as entrusted by the Chairman.
- SECRETARY/CORRESPONDENT: The Secretary shall assist the Chairman in all matters for smooth functioning of the Society.

 b. He/She shall convene the meetings of the society and maintain minutes of the proceedings.
- JOINT SECRETARY: He has to do the work entrusted by the executive committee. He has to asist the secretary in discharging his duties. In the absence of secretary he will act as secretary.
- TREASURER: He has to maintain accounts properly alongwith the vouchers. He has to prepare the accounts of the society jointly with the secretary or chairman.

TERMS OF OFFICE:

- a. The term of office of the Governing Council shall be five years. They are eligible for re-election.
- b. A casual vacancy in the office of any of the office bearers of the society may be filled up for the real due of the term.
- c. All meetings of the members of the society shall be held in Hyderabad, as far as may be in March, once every year.

FUMDS: The funds of the society shall not be used for any purpose other than attainment of the objectives of the society.

If any portion there is left with after discussion it shall be transfered to another society with similar objectives.

11. QUORUM:

The quorum for the meeting of the Governing Council shall be three, and for a meeting adjourned for want of quorum it shall be two. The quorum for a meeting of the General Body shall be one-half of the total General Body shall be one-half of the total number of members eligible to vote and for a meeting adjourned for want of quorum it shall be one-third.

12. BUDGET:
The Governing Council shall be presented with a budget of
the income and expenditure of the society by the treasurer
once every year, and get it approved and accepted.

Amendments to the rules and regulations of the society may be made by the Governing Council, specially convened for the purpose by a two-third majority of the members present and voting and to be approved by 2/3 majority in another General Body meeting.

14. DISSOLUTION OF SOCIETY:

In case of dissolution of society all its assets and properties shall be given to some other society, after the satisfaction of all its debts to be determined by a majority of 3/4 of votes of the members present at a meeting convened to receive dissolution.

Not withstanding anything certained in these rules and regulations the first Governing Council shall be composed as specified in clause of the memorandum of association. We the undersigned members of the Governing Council of Sri Surya Educational Society do hereby certify that the above is a correct of the rules of the society.
